The European Forest Institute (EFI) is an international organisation with 29 member countries and around 120 member organisations. EFI's Headquarters are in Joensuu, Finland. EFI has several offices across Europe and a project office in Kuala Lumpur, Malaysia which supports FLEGT and REDD processes in the Asia Region.

As part of the "Keberlanjutan sAwit Malaysia dan Indonesia", i.e. "sustainability of Malaysian and Indonesian palm oil" or KAMI project, EFI is supporting national processes in Malaysia and Indonesia and international dialogue on the sustainable use of natural resources, with specific focus on palm oil. The KAMI project is aimed at: 1) developing further understanding of relevant national, international, and EU policies towards the establishment of sustainable and inclusive value chains, 2) taking stock of progress achieved in this sector, and 3) promoting cooperation and exchange with international, national, and sub-national stakeholders in Malaysia and Indonesia, including palm oil producers, on the different aspects of sustainability at meaningful scale.

Tasks and responsibilities

The Stakeholder Engagement Expert for Indonesia will be responsible for stakeholder engagement and supporting policy dialogues, and project planning, implementation and reporting in Indonesia, working in close coordination with the National Development Planning Agency (Bappenas), project partners, consultants, other stakeholders as well as the EU Delegation to Indonesia.

The Stakeholder Engagement Expert for Indonesia will:

- Support KAMI engagement with Bappenas and other national and subnational stakeholders in Indonesia;
- Support a KAMI multi-stakeholder Advisory Committee to establish Sustainability Performance Indicators and Verifiers and support associated data collection, online data platform development, and policy dialogue on sustainable palm oil;
- Liaise with relevant EFI staff members and external stakeholders on all matters related to the project implementation in Indonesia;
- Organize and participate in missions, consultations, advisory committee meetings, workshops, trainings, outreach events, etc. to support implementation of project activities;
- Prepare technical reports, briefs, presentations, and documentation related to in-country activities to inform relevant stakeholders;
- Support KAMI communication related to Indonesia in close liaison with the KAMI Communications Expert and all project partners;
- Manage operational aspects of the project in coordination with relevant team members.

Qualifications

• Minimum of four years relevant working experience in forestry, agriculture, and/or natural resource management, climate change, governance, or related field, preferably in Indonesia.

- University degree in natural resource management, forestry, agriculture, environmental science, economics, or a related and suitable field. A higher degree is an asset.
- Excellent understanding of land-use governance processes and sustainable palm oil supply chain approaches, and their implementation challenges, in Indonesia.
- Excellent analytical and networking skills, including ability to work on complex and politically sensitive issues with and forge consensus among governments, private sector, international actors, NGOs, and civil society. Experience working with the Ministry of National Development Planning/Bappenas, the Ministry of Environment and Forestry and/or other relevant ministries in Indonesia is an asset.
- Solid writing, reporting, and presentation skills.
- Demonstrated project management skills.
- Professional proficiency in English and Bahasa Indonesia is required.

Duty station and travel

The Stakeholder Engagement Expert for Indonesia will be based in Jakarta, Indonesia with frequent missions within Indonesia. Some missions to Malaysia and Europe are foreseen.

Conditions

The in-house consultant can only be contracted in a personal capacity, not through another legal entity. The in-house consultant is expected to work 'full-time' (complete working weeks) over the contract period which will be 24 months. The initial contract period may be extended. Applicants can propose an hourly rate in his/her application. Such an hourly rate shall include all costs necessary for implementing the tasks (i.e. appropriate insurance organized by the in-house consultant himself/herself).
